have agreed as follows:

***Article I***

Zdravotní klaun, o.p.s. is a non-profit organisation that operates nation-wide to bring humour and joy to hospitalised children, geriatric patients and others in need in the health sector, thus contributing to the improvement of their mental and, by extension, overall health, through specially trained health-clowns and related projects.

The Donor wishes to make a donation in order to contribute to the purpose of Zdravotní klaun, o.p.s.

## Article II

### 1. Subject-matter of the Donation Agreement

- 1.1 The Donor agrees to provide a financial donation (hereinafter the „**Donation**“) to the Donee for the purpose of financing the programmes of Zdravotní klaun, o.p.s. in accordance with its statute.
- 1.2 The Donee agrees to accept the Donation and use it solely for that purpose, otherwise it is obliged to return the Donation.

### 2. Amount and form of the Donation

- 2.1 The amount of the Donation is **CZK** (in words: Czech crowns), which will be provided by the Donor to the Donee on a one-time basis and the amount will be transferred by bank transfer to the Donee's account indicated in the heading of this Donation Agreement no later than 10 days after the conclusion of this Donation Agreement.
- 2.2 The following variable symbol will be indicated by the Donor for the bank transfer:

### 3. Other information

- 3.1 The Donor does not require that its anonymity must be maintained in the Donee's annual report under Section 359 of Act No 89/2012 Sb., the Civil Code, as amended.
- 3.2 This Donation Agreement and any rights and obligations arising out of or in connection with this Donation Agreement are governed by the provisions of Act No 89/2012 Sb., the Civil Code, with the exception of those non-mandatory provisions whose application is excluded in this Donation Agreement.
- 3.3 The Donation Agreement may only be amended in writing. For that purpose, written form is not deemed to include the exchange of e-mail or other electronic messages or notices.
- 3.4 The Parties expressly acknowledge that the terms and conditions of this Donation Agreement are the result of negotiations between the Parties and each Party has had the opportunity to influence the contents of these terms and conditions.
- 3.5 The Donation Agreement is executed in two original copies, of which each Party will receive one copy.
- 3.6 The Donation Agreement becomes effective upon its execution by the last Party.
- 3.7 The Parties declare that they have read and understood this Donation Agreement and agree with its contents, in witness whereof they attach their signatures.
